<b>Section 1 – Definitions.</b>		
<p><b>Adapted Material</b> means material subject to Copyright and Similar Rights that is derived from or based upon the Licensed Material and in which the Licensed Material is translated, altered, arranged, transformed, or otherwise modified in a manner requiring permission under the Copyright and Similar Rights held by the Licensor. <p><b>Exceptions and Limitations</b> means fair use, fair dealing, and/or any other exception or limitation to Copyright and Similar Rights that applies to Your use of the Licensed Material.</p>

<p><b>Section 2 – Scope.</b></p>		
<p><b>License grant.</b></p>		
<p>1. Downstream recipients.</b></p> <p>1. <b>Offer from the Licensor – Licensed Material.</b> Every recipient of the Licensed Material automatically receives an offer from the Licensor to exercise the Licensed Rights under the terms and conditions of this Public License.</p> <p>2. <b>No downstream restrictions.</b> You may not offer or impose any additional or different terms or conditions on, or apply any Effective Technological Measures to, the Licensed Material if doing so restricts exercise of the Licensed Rights by any recipient of the Licensed Material.</p>		
<p><b>6.
